### **Personal data that we process**

Stichting Jbay surf house processes your personal data because you use our services and/or because you provide them to us yourself. Below you will find an overview of the personal data we process:

- First and last name
- Gender
- Date of birth
- Place of birth
- Address details
- Phone number
- Email address
- Bank account number

We only process (part of) your data in case of a (periodic) donation, sponsorship or volunteering or a registration for our newsletter.

### **Purposes and legal bases for processing personal data**

Stichting Jbay surf house processes your personal data for the following purposes:

- Handling your payment
- Sending our newsletter
- To deliver goods and services to you

Stichting Jbay surf house also processes personal data if we are legally obliged to do so, such as data that we need for our tax return.

## **Automated decision-making**

Stichting Jbay surf house does not make decisions on matters that may have (significant) consequences for individuals based solely on automated processing. This concerns decisions that are made by computer programs or systems, without a human being (such as an employee of Stichting Jbay surf house) intervening.

## **How long we keep personal data**

Stichting Jbay surf house does not keep your personal data longer than strictly necessary to achieve the purposes for which your data is collected. We apply the following retention periods for the following personal data: 5 years, unless a request is made to delete the data earlier. Please see the latter part of this privacy statement for more information on how to do so.

## **Sharing personal data with third parties**

Stichting Jbay surf house only provides to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

## **Cookies, or similar techniques, that we use**

Stichting Jbay surf house only uses technical and functional cookies. And analytical cookies that do not infringe your privacy. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferred settings. We can also use them to optimize our website. You can opt-out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete any information previously stored via the settings of your browser.

## **View, modify, or delete data**

You have the right to access, correct, or delete your personal data. Additionally, you have the right to withdraw your consent for data processing, or to object to the processing of your personal data by Stichting Jbay Surf House, and you have the right to data portability. This means that you can request us to send the personal data we have of you in a computer file to you or another organization of your choice. You can send a request for access, correction, deletion, data portability of your personal data, or a request to withdraw your consent or object to the processing of your personal data to [info@jbay-surfhouse.com](mailto:info@jbay-surfhouse.com). To ensure that the request for access has been made by you, we ask you to provide a copy of your ID with your request. Please black out your photo, passport number, and Citizen Service Number (BSN) in this copy to protect your privacy. We will respond to your request as soon as possible, but within four weeks. Stichting Jbay Surf House also wants to inform you that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority. This can be done via
